TTIP threat to democracy

David Malone

On December David Malone of Scarborough—film maker, researcher and writer—spoke knowledgeably and with great concern about the

Transatlantic Trade and Investment Partnership (TTIP) to a group of some 50–60 people at the Friends Meeting House in Hull. His title was 'The Death of Democracy'.

We learned a lot and realised that our democratic way of governance (such as it is) is in extreme danger and our much prized legal structures can do nothing to protect us.

A 'Russian Doll'

TTIP is the outer layer of what David described as a three part 'Russian Doll'. Partnerships, per se, do not constitute a threat; there is nothing new in Trade Agreements. It's the two inner 'dolls' that enable transnational companies—mostly based in the US—to sidestep national government decisions and legal challenges. These are the Bilateral Investment Treaty of 1959 and the Investor-State Dispute Settlement (ISDS).

One of the current US aims is to harmonise regulatory mechanisms, with the EU initially and then globally. David pointed out that the EU has struggled long and hard to achieve a very much higher standard than the US and elsewhere. 2006 saw standards being agreed across the

EU in relation to pest control, animal welfare, human rights and wages and much more. In contrast the US standards date back to 1976 and have not been updated as new products have been developed. The US does not accept the need for labelling for the inclusion of a GM product or country of origin for example. Of the 80,000 new chemicals that have been introduced into products and the environment since 1976 only 200 have been tested for safety. **US law assumes that something is safe unless there are studies to prove otherwise.**

David mentioned that in relation to fracking, US law states that it is safe. But it has not been tested.

US companies are looking for access to two of our markets in particular—health and food and agriculture.

If our government agrees to all this, we would be effectively replacing our Farm to Fork standards with US standards and agreeing to the potential increase in privatisation of our health services.

No rights of appeal

Disputes would not be dealt with by our law courts. They would go to an 'arbitration' panel composed of corporate lawyers, many of whom are also employed by the large international companies. Other people have no representation, and there is no judicial review. By this system three individuals decide on

Further clarification from Biofuelwatch of implications of Drax conversion to burning wood pellets

In the southern US, the impacts of pellet production by one of Drax's key suppliers, Enviva (the largest US pellet producer) are being studied closely by an alliance of three conservation organisations: Dogwood Alliance, Southern Environmental Law Center and NRDC (Natural Resources Defense Council).

Enviva uses hardwood from southern US coastal wetland forests (bottomland hardwoods) to make pellets. Drax don't deny that this is where a significant proportion of their pellets come from, but they (and Enviva) claim that they're only using low-quality wood for pellets and that the higher quality wood is going to sawmills, and they call this "residues". It is true that around 30% of wood, from the largest trees goes to sawmills but without the new additional

demand for the remaining 70% of wood there'd be no incentive for forest owners to clearcut the entire forests. Without the demand for pellets, forest owners would want to leave the 70% of smaller trees to grow and would at most be undertaking selective logging.

At the last Drax AGM, a company spokesperson admitted that the first converted unit relies on hardwood, claiming that the next unit conversion would be different and allow softwood to be burned (no idea whether this will be true). In the southern US, native forests are hardwood forests whereas all plantations are softwood.



Biofuel—exposing false green solutions

The November 2014 talk arranged by Hull FoE and Transition Hull, entitled **Biofuel—exposing false green solutions**, explored all the reasons why biofuels are not a green answer to the challenge of moving away from fossil fuels.

Duncan Law, a member of Transition Town Brixton and a campaigner with Biofuel Watch UK, came up from London to deliver an excellent, fact-filled talk supported by data and illustrations.

One main concern is the **destruction of forests and the biodiversity associated with them**. Although there are a variety of sources for biofuel, the majority is sourced from wood. Companies may claim to use wood waste, but the fact is that the biofuel industry as a whole is driving large-scale deforestation. In addition, biofuels from other sources, eg corn, wheat, rapeseed, are using agricultural land which might otherwise produce food.

Other concerns include **pollution from burning biomass**, which is far more problematic than acknowledged, with some communities suffering serious health effects. The **transportation of biomass** half way round the world from source to place of use is another negative aspect of the industry.

Biofuels are classed by the government as a renewable energy source. However, the **carbon savings seem to be based on questionable accounting** which does not take into consideration the time it takes for new trees to grow, pollution or transportation overheads. It is thought that in fact most biomass in current use is worse than coal over 1-2 generations. There is an urgent need to raise public awareness about the fact that **biomass is not a renewable energy source** like wind, solar, hydro and tidal generation, and that it causes severe detriment to the environment in terms of destruction of forests and biodiversity.

One of Biofuelwatch's current campaigns focuses on **Drax power station and the import of biofuel for it via Hull**. See the Transition Hull website www.transitionhull.co.uk to access the slides from the talk, links to further information and ways to get involved, under the post *Biofuel—exposing false green solutions*.

Also on the website is a post: *Biofuel—exposing false reports* which gives a response to a December 2014 report by American academics urging the British Government to promote the biofuel industry.

the outcome in private hearings with no rights of appeal.

The entire system is designed to protect the profits and products of transnational companies from democratic governments. David ended his talk by reminding us that this was happening on our watch. We are responsible for this world today and the legacy we are leaving for our children. Our task is to find ways of dealing with this issue and countering the propaganda.

A Brighter Future Together

What we do

Bameen's activities centre on practical responses to environmental concerns and their communal impact.

Environmental concerns and activities have seen substantial growth among the community generally. The response among BMEs* has however been more limited. This leads to a situation where the social and economic benefits of these activities are not felt by minority communities to the depth they could be. The reasons for this lack of engagement are many but Bameen's concerns centre on these economic and social disadvantages. Bameen seeks to develop projects that will improve the wellbeing of minority communities and lead to greater integration with the wider community. By addressing issues such as recycling, food growing and health, Bameen believes it is also tackling concerns over skills and employability which has resonance and impact upon the whole community.

Growing food

Bameen is currently running an urban agriculture project supported by the European Union. This is a free course for unemployed BMEs in Hull to equip themselves in transferable

skills. It looks at why we grow food and the benefits, what skills do we need, organising and managing a grower's session, marketing and outlets for produce, building a business and personal development etc.

Energy saving

Bameen has also been working with charity Change Agents UK in the past three months on a Department of Energy and Climate Change programme (DECC) called the Big Energy Saving Network (BESN). Bameen deliver this through its network by offering personalised **free** advice that will help bring the cost of energy bills down. Bameen help community groups, frontline staff/volunteers or individual consumers make informed decisions about payment options, tariffs, switching and energy efficiency schemes. We delivered this programme on an assist action which means we help consumers towards concrete actions through advising and signposting.

Bameen's style of delivery is to put the issues out into the communities in a manner which is culturally targeted, and through meetings and

other events examine how acting on them can benefit communities. Bameen creates and strengthens networks between minority communities and with the wider community. Bameen's work is not so much about bringing attention to minority communities' environmental issues. It is more about drawing out from those communities through their traditions, skills and practices their own understanding of them. Through this work Bameen can identify weaknesses in understanding as well as help equip communities to better relate and engage with the environments they now have made their homes.

Investing in my roof

I had been thinking about getting PV panels installed for quite a few years, especially as my roof faces directly due south. In October I had a fixed term bond mature, and with the extremely low interest rates, I thought I might as well have my money on the roof—at least I'd get a better return.

Golden rule: get 3 quotes

I got 3 quotes: I contacted Richard Haworth about the company he had used for his house (See ECO May 2014) Duncan Renewables; I also contacted Pure Renewables; and at the Green Fair in November I made contact with Humber Energy. The last proved to be the cheapest, being about £1300 less than the other two.

Humber Energy were able to fit my panels in December—thankfully before the feed-in tariff went down.

Work begins

My installation was planned for a Monday, so the scaffolding went up on the Thursday prior while I was at work, and the team (2 roofers and 2 electricians) arrived on the Monday at about 8 am. I was most impressed with them—they were polite, even took their shoes off the first time when going upstairs, and cleared up after themselves! My house is quite modern so the installation was straightforward, and quick; the roofers had finished by about 11.30 am, and the electricians just over an hour later.

Some technical stuff

What you have, apart from the panels on the roof, is an inverter box in the loft (to convert the DC current generated by the panels into AC suitable for the grid and household usage), a couple of isolators so that the panels can be isolated if need be, and the generation meter, which is only a couple of inches square and not obtrusive at all. A cable runs down the outside wall from the loft (and inverter) and into the house again to connect to the fuseboard. The generation meter is next to the fuseboard in the kitchen, and it's quite interesting coming home after work when the sun has been out to see how many units have been generated.

And the bottom line...

The cost, for a 1.5Kw array of 6 panels (all I had room for on my small roof) was £2,950. They have a 25 year guarantee. Currently I get paid 14.38p per unit generated (the feed-in tariff). The assumption is made that I will use 50% of the amount generated myself, and 50% will be sold to the grid for which I get an additional sum.

Was it worth it?

People have asked how long the return period is, and I was told 7 years according to the calculations, but I'm just thankful that I'm able to generate some electricity and so reduce my carbon footprint, get a reduction on my electricity bills, and pass what I don't use onto the grid.

I also wanted to have hot water but that is more complex (you have to make sure your boiler is adequate) but I think I will wait until the prices come down, and/or I move house.

Go for it!

I'm happy with what I've got and would urge anyone with a (smallish) lump sum to consider having panels—you're likely to get a much better return than the banks are able to give.

certainly have moved on when you read this. And there will probably have been new developments at the planned new sites for exploration at West Newton. You might like to take a trip to talk to the protectors' camp at Crawberry Hill. They are now under threat of eviction, but whatever happens they won't go far!

You might also like to look further afield. And not just at what is happening at the many other fracking sites throughout the UK. It is also worth noticing what is happening in other countries and politically. For instance...

► On 6 January the Guardian reported that the fall in prices for oil, now at \$55 a barrel, could cause the fracking money bubble to burst, as it

costs \$60 a barrel to produce oil by fracking.

- The issue of fracking is becoming a major debate factor in the upcoming state elections in Queensland, Australia: www.lockthegate.org.au
- France has an extended moratorium on fracking, thanks to the excellent work of anti-fracking groups there. But it is fragile. To explore their very useful material in English, including well thought out arguments for debate situations go to www.schistehappens.blogspot.co.uk
- Fracking accidents, statistics. If you need to frighten yourself or others a little more try <http://www.nofrackingway.us/2014/12/31/spill-baby-spill-kill-baby-kill-2014-in-fraccidents-and-frackastrophes/>
- In May last year a Colorado well leaked 80–100 gallons per hour for 30 hours. Much of this went into the Colorado river's largest tributary, the drinking water source for 35 million people. (And four endangered species of fish.)
- The USA's biggest methane "hot spot," verified by NASA and University of Michigan scientists in October, is only the most dramatic example of what scientists describe as a \$2 billion leak problem: the loss of methane from energy production sites across the country.
- In the USA fracking is putting more radioactive wastes into the environment than all their nuclear plants combined. <http://www.nofrackingway.us/2014/05/04/fracking-produces-more-radioactive-waste-than-nuclear-power-plants/>

Yet more on the fracking scene...

Hull City Council on 20 November approved unanimously a motion opposing fracking. It noted a list of dangers, referred it to Scrutiny Committee, sent it to the government, and declared:

'This Council believes that the future for this region is in developing the potential of the green, renewable energy generation industry and moving away from depleting resources of fossil fuels that damage the environment and lead to climate change.'

East Riding residents now hope they can use this as leverage to move their Council to be more responsible in its dealings with exploratory companies like Rathlin and not merely rubber-stamp whatever they say.

- ▶ Oil and gas company Third Energy have announced plans to frack at their wellsite in the village of Kirby Misperton, between Pickering and Malton. They have also applied for planning permission to reinject contaminated water from a conventional drilling well into the sandstone. This technology has been used by fracking companies in the USA and has been linked to a higher level of seismicity and leakage of pollutants. Friends of the Earth is working closely with local residents from Frackfree Ryedale to oppose these proposals.
- ▶ The Government has introduced the Infrastructure Bill into Parliament. This draft legislation will (a) remove the right of landowners to be notified if horizontal drilling is being proposed under

their property and (b) allow drilling companies to dispose of their waste underground. You can object on <https://secure.greenpeace.org.uk/page/s/tresspass-law-fc>

- ▶ More Government measures to support the fracking industry were announced recently when the Government pledged public money for monitoring equipment to try to prevent groundwater pollution. Friends of the Earth questioned why this isn't being paid for by the industry.
